### 1. Terms of Use

#### 1.1 INTRODUCTION

This document, in conjunction with any documents referred to in it (including our privacy policy), describes the terms of use on which you may make use of our website ([www.razzledazzleschool.co.uk](http://www.razzledazzleschool.co.uk)), and any other associated websites as listed in appendix A (“our sites”).

Please read these terms and conditions carefully before using our sites, as the use of any of our sites constitutes your acceptance of these terms and conditions and any subsequent modifications thereto. If you do not agree with any of these terms please refrain from using any of our sites.

#### 1.2 INFORMATION ABOUT US

Our sites are operated by Razzle Dazzle Stage School (“we”, “our” or “us”)

#### 1.2 ACCESSING OUR SITES

Access to our sites is permitted on a temporary basis, and we reserve the right to withdraw or amend the service we provide on our sites without notice (see below).
